INSTRUCTIONS

(Read carefully before filling the form)

1. Examination admission form complete in all respect should reach to the office of the Controller of Examinations, University of Swat on or before the last date with normal fee notified for the purpose, failing which late/double/triple fee shall be charged.
2. University will not be responsible for any late delivery of examination admission form and the candidate has to tackle his/her case by herself/himself with the postal/courier services.
3. All candidates are required to attach three passport size attested recent photographs, a copy of CNIC and domicile certificate duly attested by the Head of the Institution/Principal/Gazetted Officer with the examination admission form. The attesting officers will be held responsible for any wrong/incorrect information.
4. Temporary residents of District Swat, Shangla and Buner who want to appear in B.A/B.Sc examination have to produce residential certificates from the respective Tehsildar and NOC from the concerned local University.
5. Fee once deposited is neither refundable nor adjustable if the candidate is otherwise eligible.
6. Federal/Provincial service personnel or their children who are not permanently residing in the jurisdiction of the University of Swat, shall be required to attach service certificate of their own or of parents along with the examination admission form. Service certificate of Private Service shall not be acceptable.
7. Admission fee deposited in other than specified bank branches will not be accepted.
8. Every candidate must affix thumb impression and sign the examination admission form himself/herself. In case of any variation of thumb impression or in signature from CNIC, the candidate will face impersonation charges.
9. Two different examinations are not allowed in same session, except examination for the improvement of division as permissible under the rules.
10. The examination center will be allotted by the university where feasible and not on the choice of the candidate, without caring the address of the candidate.
11. Incomplete form shall not be entertained.
12. For improvement of division, the candidate will be required to appear either in both parts simultaneously, or in the Part-II examination only, in such a case a candidate will have to appear in the syllabus in vogue of the relevant examination within two consecutive years.
13. A Candidate of BA/B.Sc will avail a maximum of five & four consecutive examinations for Part-I & Part-II respectively, including the initial one to clear all the papers as well as in aggregate, failing which he/she will be required to appear in all the subject including practical examinations as a whole. This decision will be applicable to both regular & private BA/B.Sc students as well as candidates failing in aggregate.
